WHO IS AMOR?

## INTRODUCTION

AMOR is a rapid response network created by six grassroots organizations in January 2017 to address individual acts of violence against community members (such as targeted hate crimes) and general acts of statesponsored violence (such as localized ICE raids) in Rhode Island. In 2017 right after the Trump administration took office, these organizations foresaw the personal and systemic attacks that

immigrant, refugee, and vulnerable groups were going to face, and were motivated to unite and create the AMOR Network

AMOR takes a dual strategy that 1) seeks to meet material needs through community-based working teams and 2) addresses the root causes of state violence through targeted advocacy initiatives. Our

working teams organize community members, volunteers, partner organizations, and staff to provide and share resources from legal aid, mental health resources, transportation to and from legal appointments, and interpretation. Our advocacy initiatives focus on advancing legislation that expands immigrant rights, increasing awareness of legislation that benefits the community, amplifying the presence and demands of Rhode

Islanders impacted by systemic racism, and challenging racist institutions such as immigrant detention facilities. Through our initiatives, AMOR programs know-your-rights workshops, forums for the community to learn and discuss legislation that affects their lives, and enrollment sessions into benefits that are often possible as a direct result of bills which AMOR organized into legislation.

#### MISSION & VISION



#### **MISSION**

AMOR is a nonprofit organization in RI, that organizes to interrupt state violence and supports people impacted by the immigration system. We are organizing to place sovereignty back into the hands of communities directly affected by systemic oppression and to build leadership, generate power, create sustainability and organize resistance with and alongside all directly affected peoples.



#### VISION

AMOR envisions a world where the community has the power to ensure sovereignty. Where families do not fear being separated due to their documentation status and where black and brown communities are able to protect themselves against police violence and immigration raids. AMOR envisions a world where mental and physical health are the number one measure of community safety. Furthermore we envision a society where individual acts of hate and state sponsored hate are defeated by frontline community resistance.



## CASE MANAGER REPORT

### PERIOD OCTOBER 20, 2023 - JUNE 20, 2024

During the period October 20, 2023 to June 20, 2024, we have handled a total of 89 Cases and managed 208 service requests. These services have covered 29 different areas of resources and support. The majority of our cases have come to our office in need of assistance in matters related to their immigration status and legal procedures related to immigration status.

CASES HANDLED IN PERSON AT THE OFFICE = 70 REQUESTS HANDLED THROUGH DEFENSE LINE = 19


TOTAL SERVICES PROVIDED= 208

#### **DEMOGRAPHICS**

AMOR is committed to supporting folks who are unable to access support from other organizations and service agencies.

#### **FOCUS**

In 95% of our cases, the main request and need has been for help with their immigration process and the need for monetary resources for the immigration procedures. This reflects the high demand and predominance of this need in our community.

#### **COMPLEX CASES**

We have identified 6 complex cases that have required assistance in more than 9 service areas. These cases have required special attention due to the complicated nature of their immigration legal processes and insufficient discretionary funds to resolve these requests.

#### **ANALYSIS OF REQUESTS**

In 95% of our cases, the main request and need has been for help with their immigration process and the need for monetary resources for the immigration procedures. This reflects the high demand and predominance of this need in our community.


In addition to the predominant services mentioned above, we have offered a wide range of services and/or resources in 29 different areas, demonstrating our willingness and ability to adapt, solve and address the needs of our cases.

Although AMOR faces challenges in financial resources, we have been able to assist these 89 cases in this time period. not only in their aforementioned legal needs but also in other crucial areas that improve their quality of life.

Here is a window into the different types of support that have been provided to clients and community members seeking support.

#### **CHALLENGES**

Immigration legal cases tend to be complicated, extensive and very costly, which is beyond the financial capabilities of these families in our migrant community.



#### **SOLUTION**

We have expanded and extended our assistance and services to other areas where we can offer support such as: Health insurance management, medical care, financial assistance on medical bills, public benefits,

utility payment subsidy and basic utilities, electric power, heating, accompaniment and transportation to immigration court, workers' compensation cases, workers' rights counseling, privilege leave management, emotional counseling, food and nutrition programs, etc.

We look for ways to tap into available resources to ensure that our cases receive the help, support or assistance needed, even when we are unable to handle it directly, we turn to other means of support.

## IMPACT AND SATISFACTION OF OUR CLIENTS AND COMMUNITY MEMBERS

Despite the above challenges we have been able to satisfy our caseload in areas and requests in which they do not expect to be entitled or qualify for support. We have been able to provide them with tools in areas that they themselves unfortunately do not have the capacity or facility to handle. This ability to offer solutions beyond expectations has been key to improving the overall well-being of these families in our community.

#### **CONCLUSION**

My commitment as a case manager is reflected in the diversity of services offered and the comprehensive care, as well as the compassion, support and delivery to the needs of our clients and community members.

Throughout this period I have demonstrated the capacity and willingness that AMOR has in carrying out its mission as well as the ability to adapt and overcome financial limitations, ensuring that our community receives the necessary support for its procedures and other vital needs.

## **COMMUNITY EVENTS**

#### 2024 EVENTS OVERVIEW

The year 2024 has been significant for the immigrant community thanks to a series of events organized with the goal of informing, educating and strengthening our community connections. These events not only provided vital resources, but also fostered unity and empowerment among participants.



#### **JANUARY 2024**

The first event of the year, "Know Your Rights," was held on January 23rd through Zoom, this informative and educational event focused on empowering the immigrant community by providing them with crucial information about their rights. The high participation and interest showed the community's need and desire for this type of information, underscoring the importance of continuing with similar events in the future.



#### **FEBRUARY 2024**

On February 20th, the "Bundle up with AMOR" event provided not only warm clothing, but also a space for community members to connect and strengthen their relationships. This event, highlighted the importance of creating a united and supportive community.



#### **MARCH 2024**

In March, significant events were held for women in the community. On March 8, Women's Day was commemorated with a message of support and struggle spread on social networks. On the same day, the event "Mujeres Empoderadas" (Empowered Women) brought together immigrant women to discuss crucial issues such as patriarchy and violence against women. This event was a space for empowerment and solidarity among women.



#### **APRIL 2024**

On April 9, the "Motivational Workshop" offered inspiration and motivation to the community, with the participation of Sylbia Bernal as speaker, this workshop highlighted stories of empowerment and fostered a sense of hope and determination among attendees.



#### **MAY 2024**

On May 7, an important event on "Immigrant Labor Rights" was held. This event was organized with Gregory Pehrson as a speaker. The session was vital in educating the community about their labor rights, increasing their knowledge and understanding of this essential topic.



#### **JUNE 2024**

On June 21, the "Community Care Day / Healing Day" provided a space for healing and wellness for the community. With activities such as skin care, massages, and photo stations, this organized event promoted community cohesion and wellness. The activities were well received and it was suggested to include more options for children in the future.

#### **GENERAL COMMENTS**

Overall, the events organized in 2024 have shown a high level of participation and interest, especially in topics related to rights, wellness, and empowerment. These events have been instrumental in strengthening participation and mutual support within the immigrant community. The positive response to these activities highlights the importance of continuing to provide resources and connecting spaces for this community. The effective planning and execution of these events demonstrate the organizers' commitment to creating an inclusive and supportive environment.

This year AMOR worked with other like minded community organizations to advocate for bilingual education in Rhode Island.



#### **COMMUNITY RESPONSE TEAM**

to adjust their status, causing more people to face deportation and family separation.



# THIS YEAR AMOR HIRED A TEAM TO HELP FACILITATE OUR FIRST EVER STRATEGIC PLAN PROCESS.

In the last seven years we have learned a lot from our work, from our people, and the nonprofit system. We need to strengthen our work and focus on the part that has worked well and needed most in the community. We need to find the balance between supporting our communitywith directservices, our campaigns, and our organizing work with the health and care of our staff members and volunteers. The needs in our community have increased more than ever in the last seven years: immigration issues, deportation, housing crisis, healthcare, food, access to language, transportation. Our staff and volunteers continue to be committed to this incredibly hard work in our community, especially because our staff and volunteers are people of color that are directly impacted by these issues.

In the past two years, we've experienced growing pains as we became a 501c3 in the beginning of the pandemic. We established a new Board and working on its development; we've had staff transition from burn out; we've developed and troubleshooting internal personnel, financial, and structural policies; we are restructuring our work to match our capacity; and we want to realign our staff, board members, and volunteers by revisiting and reaffirming AMOR's mission and vision. We hope to do all of this through a strategic planning process.
